

Please read carefully before signing as this is a legally binding contract. **Each traveller must sign a separate** *form*. A parent/guardian must sign for minors under 18 years of age.

In consideration of the services ("tour") provided by Uncover the World Travel Ltd. ("Encounters Travel", "we," or "us"), I, an adult traveller or parent or legal guardian of a traveller who is a minor (under 18 years of age; the "Child" or "Minor"), acknowledge and agree to the following terms and conditions to the maximum extent allowed by law on my own behalf or, if applicable, on behalf of the Child

GOVERNMENT TRAVEL ADVICE:

I have read and understand the <u>UK Government Foreign, Commonwealth & Development Office ("FCDO")</u> <u>travel advice</u> for my destination (as well as any travel advice provided by my own government should I not live in the UK).

I understand that the FCDO currently advises 'against all but essential travel' to my destination.

I understand and accept the risks of travelling to my holiday destination irrespective of the advice given by the FCDO (as well as the advice provided by my home government should I not live in the UK).

MEDICAL SELF ASSESSMENT

I understand that it is very important that I carry out an honest self-assessment of my health before setting off to join my tour.

I agree to make an online medical self-assessment and declaration within 7 days of my departure to confirm that I understand the risks of travelling during the Covid-19 pandemic, that I am free of symptoms and have not been requested to self-isolate for any reason by my local health authority. I accept that I may not be allowed to join the tour should I not be able provide this, and that in such an event, while Encounters Travel's '<u>Flexible Booking Conditions</u>' will apply to my booking, I may not be due a refund if I am not able to travel or re-schedule.

TRAVEL INSURANCE:

We strongly recommend you check your travel insurance policy wording to check it provides cover for Covid-19 related events and to countries which your home government may advise against travel to. Please contact us if you would like suggestions for travel insurance policies that do provide this level of cover.

Applicable Law and Choice of Forum:

Any dispute arising out of this agreement, including all tort claims – whether such dispute arises in contract or in tort or otherwise ("Dispute") – shall be litigated and determined, if at all, only before a court of competent jurisdiction in England or Wales.

Knowing and Voluntary Execution:

I have carefully read and understand the provisions and legal consequences of this agreement, and I hereby agree to all of its conditions. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect. I understand that in calculating the cost of the tour, Encounters Travel has relied on my consent to these terms and their enforceability. Without this agreement, the tour cost would have been higher or, alternatively, Encounters Travel would not be able to offer these services.

I agree that electronic transmission of an executed copy of this agreement shall constitute acceptance of this agreement.
